### OPERATOR PARTICIPANT CONTRACT

THIS AGREEMENT SETS FORTH THE TERMS AND CONDITIONS UNDER WHICH WE, Blanco International Service, Inc. in return for payment of the amount indicated as the total charter price, agree to provide you this charter flight. Your rights and remedies set forth in the Operator Participant Contract, including the procedures for major changes, are in addition to any other rights or remedies available under applicable law, although Blanco may condition a refund on your waiver of additional remedies. **RESPONSIBILITY:** We, as the principal, are responsible to you for arranging the charter flight, provided however, that in the absence of negligence on our part, we are not responsible for personal injury or property damage caused by the air carrier or other suppliers of any of the services offered in connection with the charter. **RESERVATIONS AND PAYMENT:** Attached to this Agreement is your Reservation Form. We will confirm the reservation within 7 days after receiving the Reservation Form. If the charter flight is fully booked, we will advise you of alternate travel dates. The ticket will be issued only after the reservation is confirmed, and you must pay the full charter price when the ticket is issued. All checks, money orders, and credit card drafts must be made payable to your travel agent, who in turn must remit payment to **BLANCO INTERNATIONAL SERVICE, INC.** **CHARTER PRICE:** The charter price of \_\_\_\_\_ represents your cost for a charter flight that departs from \_\_\_\_\_ to \_\_\_\_\_, Cuba on \_\_\_\_\_ and returns from \_\_\_\_\_, Cuba to \_\_\_\_\_ on \_\_\_\_\_. **Excess baggage charges are NOT included in the charter price and will be collected separately.** **AIRCRAFT:** This flight will be performed by \_\_\_\_\_, operating an aircraft with \_\_\_\_\_ passenger seats. **This air carrier reserves the right to substitute equivalent aircraft, if necessary.** **INSURANCE:** Health insurance is available. If you are interested in receiving more information about this coverage, please advise your travel agent. **BAGGAGE:** The air carrier allows each passenger to bring on the flight 44 pounds of baggage. The excess of 44 pounds of baggage will be collected in the airport @ \$2.00 per pound to Havana and Manzanillo, and \$2 to Santiago de Cuba. Additional, a charge of \$20.00 will be collected for each piece of checked baggage. Irregular luggage will be priced @ \$2 per lbs. For **INTERNATIONAL flights**, the air carrier's liability is limited to the actual value of the baggage, but not more than approximately \$9.07 per pound in the case of checked baggage and \$400.00 per passenger for unchecked baggage. If, however, you declare a higher value for your baggage and pay an additional charge therefore in advance, the air carrier's liability will be higher. You must submit your claim to the air carrier or to us within 3 days of the charter flight. Your claim must include a copy of the Baggage Check. Unless the Baggage Check specifies the actual weight, we will presume that each checked bag weighs 44 pounds. In this case, liability is limited to \$400 per checked bag. **SECURITY AGREEMENT:** Your payment is protected by a surety bond that we have obtained from, Lexon Insurance Company. Unless you file a claim with us, or, if we are not available, with Lexon within 60 days after the completion of the charter, Lexon will be released from all liability to you under this Security Agreement. **CANCELLATION AND REFUND:** If you cancel your reservation or if you fail to travel on the charter flight, your right to receive a refund is limited, as set forth: **If your notice is received: 7 to 4 days before departure, you will receive: 50%. If your notice is received: Within 3 days before departure you will receive: No Refund.** At any time, if we are able to resell your seat, you will receive: A full refund less \$25.00 administrative fee. All requests for refunds must be sent to us in writing or by facsimile. Refunds will be made within 14 days of receipt of your notice of cancellation. **INTERNATIONAL FLIGHTS:** The operation of the charter flight is subject to the Cuban government granting landing rights. If the air carrier cannot obtain landing rights, the flight will be cancelled, and a full refund will be made to you automatically. **MAJOR CHANGES:** If Wilson International Services, Inc. makes major changes prior to departure, you have the right to cancel the reservation for the charter flight and receive a full refund. The following situations constitute major changes: (1) a change in the departure or return date shown in this Operator Participant Contract, unless the change results from a flight delay. In any event however, a date change that BLANCO knows of more than 2 days before the scheduled flight date, and any delay of more than 48 hours, will be considered a major change; (2) a change in the origin or destination city of any charter flight, unless the change is only in the order in which the cities are flown; (3) a substitution of any hotel that is not named in this Operator Participant Contract; (4) a price increase that occurs 10 or more days prior to departure. If Wilson knows of a major change 10 or more days before departure, Wilson will notify you of the change within 7 days after first knowing of it, but in any event at least 10 days before scheduled departure. If BLANCO first knows of a major change less than 10 days before departure, BLANCO will notify you as soon as possible. **Within 7 days after receiving a pre-departure notification of a major change, but in no event later than departure, you may cancel your reservation and receive a full refund within 14 days after such cancellation. Upon a post-departure notification of a major change, you may reject the substituted hotel or the changed date, origin or destination of a flight leg and be sent, within 14 days after the return date named in this Operator Participant Contract, a refund of the portion of your payment allocable to the hotel accommodations or the air transportation not provided."**

**NOTICE OF BAGGAGE LIABILITY LIMITATIONS:** Liability for loss, delay, or damage to baggage is limited unless a higher value is declared in advance and additional charges are paid. For U.S.-Cuba and other international travel (including domestic portions of international journeys) to which the Montreal Convention applies, the liability limit is 1,000 Special Drawing Rights (approximately \$1,500) per passenger for all baggage, including carry-on. Additional information on Special Drawing Rights is available at www.imf.org.

**ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY:** Passengers on a journey involving an ultimate destination or a stop in a country other than the country of origin are advised that the provisions of the Montreal Convention are applicable to the entire journey, including any portion entirely within the country of origin or destination. For passengers on a journey to, from, or with an agreed stopping place in the United States of America, the Convention provides (1) that liability of the carrier for death or personal injury to passengers of up to 100,000 Special Drawing Rights (approximately \$150,000) per passenger shall not depend on negligence on the part of the carrier, and (2) such liability shall be limited to 100,000 Special Drawing Rights (approximately \$150,000) per passenger in the absence of negligence or other wrongful act or omission on the part of the carrier. Additional information on Special Drawing Rights is available at www.imf.org.

Additional protection can be obtained by purchasing insurance from a private company. Such insurance is not affected by any limitation of the carrier's liability under the Montreal Convention. For further information please consult your airline or insurance company representative.

**TRAVEL AFFIDAVIT**

I understand that, under current United States travel restrictions with respect to Cuba, travel-related transactions are prohibited except for the following categories and that by signing my name at the bottom of this affidavit, I am declaring that I fall under the category I have checked below:

**PEOPLE TO PEOPLE TRAVEL § 515.565(b)**

(b) General license for people-to-people travel.

- (1) The exchanges take place under the auspices of an organization that is a person subject to U.S. jurisdiction and that sponsors such exchanges to promote people-to-people contact;
- (2) Travel-related transactions pursuant to this authorization must be for the purpose of engaging, while in Cuba, in a full-time schedule of activities intended to enhance contact with the Cuban people, support civil society in Cuba, or promote the Cuban people’s independence from Cuban authorities;
- (3) Each traveler has a full-time schedule of educational exchange activities that will result in meaningful interaction between the traveler and individuals in Cuba;
- (4) An employee, paid consultant, or agent of the sponsoring organization accompanies each group traveling to Cuba to ensure that each traveler has a full-time schedule of educational exchange activities; and
- (5) The predominant portion of the activities engaged in by individual travelers is not with individuals or entities acting for or on behalf of a prohibited official of the Government of Cuba, as defined in 31 CFR § 515.337 of this part, or a prohibited member of the Cuban Communist Party, as defined in 31 CFR § 515.338 of this part.
